RadSite to Showcase Enhanced Version of MIPPA Accreditation Standards v2.2 and Online Portal at RSNA 2015

New System Supports MIPPA Accreditation Program Applicants

MAP includes a review of personnel, policies and procedures, as well as sample clinical images and phantom studies. To enhance the experience of applicants, RadSite recently released a completely redesigned version of its online accreditation application portal and software to support the program, and will showcase the new system at RSNA 2015.

"We gathered input from applicants who have applied for accreditation with RadSite over the past year," said Dr. William W. Orrison Jr., RadSite's Chief Medical Officer and Chair of the Standards Committee. - An online form wizard that streamlines completion of sections based on previous responses, allowing providers to skip sections that do not apply to their facility

“We recognize that imaging providers have to juggle many competing demands for their time, so completing what is traditionally viewed as tedious paperwork is not something many people look forward to,” said Garry Carneal, JD, MA, Chair of the RadSite Advisory Board. “RadSite is seeking to change that perception by making our new portal both intuitive and intelligent. When an online application is easy for a user to navigate and smart enough not to ask redundant questions, the entire process becomes much more efficient. We are looking forward to sharing our new portal with the medical imaging industry at RSNA 2015.”
